The Brainerd Public Utilities (BPU) Commission is offering a rebate program to BPU customers to promote the replacement of older residential electrical service entrances.

The purpose of this program is to promote electrical safety for BPU customers by eliminating the older residential electrical service entrances and to locate all electric meters on the outside of the residence.

This program will apply to existing residential customers within BPU's electric service territory with the following provisions.

To Qualify>>>>

Existing electric meter must be located inside the house.

- If existing electric meter is outside and you have a 60-amp service, you will qualify if you upgrade to a minimum of a 100-amp service.
- This program applies to both overhead and underground service entrances.

Minimum Upgrade Requirements>>>>

- Electrical meter must be relocated to the outside of the house and be accessible for meter reading and maintenance.
- All electrical work must be performed by a license contractor or the homeowner, at the expense of the homeowner.
- All material used to upgrade the electrical service entrance must be new.

- Electric service entrance must be upgraded to at least a 100-amp, 120/240 three wire service.
- An REI must be completed and filed with the State of MN.
- All work must be inspected by an electrical inspector before rebate is issued.

Rebate Procedures>>>>

- Customers must register for this program by filling out the Electrical Service Entrance Rebate application. Applications are available at the BPU Service Center or downloading the application at www.bpu.org.
- Upon completion of electrical work, the customer and the electrical contractor must sign the Electrical Service Rebate Application, if applicable.
- BPU will issue a rebate of \$500 for the upgrading of the electrical service entrance equipment in accordance with Policy 2020-01.
- All provisions of the BPU's rebate policy must be met before a check is issued to the customer.

Additional Information>>>>

BPU policy is that the customer is responsible for all underground service entrance wires out to the transformer. In overhead service entrance installations, the customer is responsible out to, and including, the service entrance stack.
